



# **COLLABORATION FRAMEWORK AGREEMENT**

In Madrid, Spain, March 5, 2016

#### **TOGETHER**

On the one hand, Mr. JOSE ANTONIO CECILIA FERRON, with ID 50780915C, the legal age, resident in the Valle del Roncal street 4-3°D- 28232 Las Rozas (Madrid, Spain)

Otherwise, Mr. Angel Diaz Fernandez, with ID 10560314W, residing in Marqués de Mondejar, Street, 32-28028 Madrid, Spain.

## THEY ARE INVOLVED

The first entity on behalf of the World Organization of Alumni Catholic Education, hereinafter OMAEC, as chairman, with registered office at Via Aurelia 476, 00165 Rome (Italy).

The second, on behalf of the PROYDE Association (hereinafter PROYDE), with CIF G-78885639 and domiciled in Marqués de Mondejar street, 32 - 28028 Madrid, Spain as director.

Both parties have sufficient legal capacity to sign this document are acknowledged and,

### **EXPOSED**

**FIRST**: That OMAEC is a worldwide organization whose objectives defined in its statutes:

a) ENCOURAGE global commitment and cooperation of Alumni Associations of Catholic Education, to safeguard the dignity and the service of the human

community without distinction, according to the principles of Catholic education.

- b) SERVE partner agencies in conducting their own purposes and stimulate relations between them understanding, mutual support and common actions based on Christian values and charisms that encourage institutions that have educated their members. (Catholic Colleges and Universities, etc.).
- c) PROMOTE the creation of world organizations alumni Institutes of Consecrated Life and diocesan Continental Unions and national federations, where none exist.
- d) PROMOTE global knowledge, affirmation and diffusion of gospel values on education, and particularly freedom of education.
- e) REPRESENT their bodies in all matters relating to common initiatives on the international level and in particular the United Nations UN and its agencies.
- f) HOLD permanently worldwide, relations with international organizations that directly or indirectly interested in educational issues and the promotion of the person.
- g) OPINION social, cultural, economic and political issues always defending Christian values related to our purposes.

**SECOND**: PROYDE which is a non-profit declared of public utility, whose institutional goals include development cooperation, education for development, fair trade - responsible consumption, promoting volunteerism.

THIRD: That the Executive Committee meeting of OMAEC held in Rome on 21 and 22 March 2015, OMAEC commitment to fair trade and responsible consumption has been adopted as a way to be changing the world for justice and the poor . To do OMAEC is committed to the dissemination among members of fair trade and taking relevant conscience. He remembers PROYDE contact the association to establish a "partnership", given its experience in the field of fair trade, responsible consumption and awareness programs.

FOURTH: Both parties define fair trade and scope:

- Fair trade is an alternative to conventional support and trading system that pursues the development of peoples and the fight against poverty.
- Alumni of Catholic Education must be sensitive and be aware that changing consumption habits, promoting fair trade and responsible consumption are a way to improve the world for the most disadvantaged.

### **AGREEMENTS**

- 1) Each party may propose to other collaborative activities, in particular the disclosure of fair trade and responsible consumption.
- Each concrete action that it is established jointly by the parties within the framework partnership agreement will be the subject of a specific agreement to be part of this agreement as Annex.

- 3) The specific agreement shall contain at least the description of the action, the commitments of each party and the temporal scope of its development.
- 4) Under this framework agreement, provided that there is at least one concrete action running, PROYDE OMAEC authorizes the use of the symbol or company name in all the hype OMAEC do with social and informative purposes in their services. For the same purpose and in accordance with its institutional objectives, PROYDE provide brochures and information about itself and its activities, provided that prompted OMAEC and depending on the availability of the same.

OMAEC, will show PROYDE prior to its dissemination, any material, bearing his monogram and / or information about their activities so that approval of PROYDE.

PROYDE OMAEC provides its graphic identity program standards and Visual document to facilitate the effective dissemination of its anagram and brands.

- 5) OMAEC, allowed PROYDE to use its symbol or company name on your page and publications, where it appears as a partner, can be specified in part or completely that their collaboration.
- 6) The expected duration of this collaboration is one year after the signing of this document, renewable annually, except express waiver of a party a month in advance.
- 7) In case of dispute regarding this Agreement, the Parties shall primarily a settlement by mutual agreement. In other circumstances, they will be subject to the courts of Madrid, Spain.
- 8) And find according to his will, they are signed in duplicate in the place and date specified in the beginning of this document.-
