1. APPROVAL OF PREVIOUS RECORD

All members of the EC have a copy of the minutes of the last EC meeting held in Rome (Italy) dated 03/21/2015. We proceed to review and correct on page 7 the country Ukraine instead of Mongolia. The minutes were approved unanimously.

2. REPORT (March 2015 - April 2016)

Chairman Mr. Jose Antonio Cecilia and Secretary General Mr. José Ramón Batiste, presented the activities carried out in the period since the last meeting of the EC:

- Efforts and contacts with the PCPL (Pontifical Council for the Laity) for approval Statutes.
- Efforts and contacts to propose appointments of several correspondents in different countries (Thailand, Japan, Democratic Republic of Congo and Chile).
- Participation in various international forums (UNESCO, Council of Europe).
- Preparation and presentation of ECOSOC-UN studies on Education, Equality of women, abuse and abortion.
- Creation and launch of a new website for OMAEC with an internal management system itself.
- Animation and contacts for the incorporation of Mexico FEDECMEX.
- Meetings and contacts with canonists and theologians for guidance on the way forward in relations with the CPPL.
- Appointment to an ECOSOC-UN representative in New York.
- Assistance to the Congress of the OIEC in Rome.
- Preparing and sending e-newsletter OMAEC World No. 14 and 15.
- Management and maintenance of Facebook OMAEC.
- Assistance European Laity Forum.
- Home contacts with the Congregation for Catholic Education.
- Sign partnership agreement with the NGO La Salle PROYDE for the promotion of Fair Trade.

The report is approved by all members; Mr. Laurent Gregoire suggests that the presentation of the activities performed by thematic blocks; also suggests the possibility that OMAEC be incorporated into LINKEDIN and that a FLYER be prepared to disseminate information about OMAEC.
